Motion by Schlaud, seconded by Maasch, **PASSED**, to approve the Road Project Agreement with Lapeer County Road Commission for a 18x45 cross tube culvert on Suncrest Drive, as presented, in the amount of 7,500.00. All ayes. Carried.

Supervisor Engelman stated to the Board that he has been in meetings with Lapeer County Road Commission Foreman Gabe Forro on the Farnsworth Road road issue. They are looking into the best way possible to fix the issue.
