The regular meeting of the Mayfield Township Board was called to order at the Mayfield Township Hall, at 5:30 p.m. by Supervisor Daniel J. Engelman, with the Pledge of Allegiance of The United States of America .

Motion by Maasch, seconded by Kile, **PASSED**, to approve the May 6, 2026 regular meeting minutes, as presented. All ayes. One absent. Carried.

Motion by Maasch, seconded by Schlaud, **PASSED**, to accept the Treasurer report for April and May, as presented. All ayes. One absent. Carried.

Public Time: Mayfield Twp representative, Carol Brown, gave the board an up date on the Library, annual meeting, agenda, website. .

Supervisor Dan Engelman, closed the regular meeting at 5:43 p.m. and opened the Public Hearing for the Mayfield Township General Appropriations Act-Fiscal Year Budget 2026/2027.

Motion by Maasch, seconded by Kile, **PASSED**, to rescind the Mayfield Township Ordinance #3700 in it's entirety. Roll call vote: Maasch-aye, Frisch-absent, Engelman-aye, Schlaud-aye, Kile-aye. Carried.

Motion by Maasch, seconded by Schlaud, **PASSED**, to adopt the Mayfield Township Ordinance #3701, noxious weed ordinance, to become effective 30 days after publication.. Roll call vote: Frisch-absent, Engelman-aye, Schlaud-aye, Kile-aye, Maasch-aye. Carried.

Supervisor Engelman introduced Fire Chief Mike Vogt to the Board. Fire Chief Vogt gave an overview of how the fire contract process was done.

Motion by Schlaud, seconded by Maasch, **PASSED**, to approve the Fire Contract with the City of Lapeer, for a term of 10 years, as presented. Roll call vote: Engelman-aye, Schlaud-aye, Kile-aye, Maasch-aye, Frisch-absent. Carried.

Motion by Maasch, seconded by Schlaud, **PASSED**, to reappoint Beth Knowlton and Bill Geisenhaver to the Mayfield Township Zoning Board of Appeals for a three year term. Ending June 2029. All ayes. One absent. Carried.

Motion by Schlaud, seconded by **DENIED**, for lack of support, to set the annual meeting date for June 11 at 5:00 p.m.

Motion by Kile, seconded by Maasch, **PASSED**, to set the Mayfield Township annual meeting date for June 23, 2026 to be held at the Mayfield Township Hall at 5:30 p.m. All ayes. One nay. One absent. Carried.

Clerk Schlaud proposed increases to the Mayfield Township Fee Schedules. Discussion was held.

Motion by Schlaud, seconded Maasch, **PASSED**, to increase the Mayfield Township Stiles Cemetery Fee increases to become effective July 1, 2026 Roll call vote: Schlaud-aye, Kile-aye, Maasch-aye, Frisch-absent, Engelman-aye. Carried.

Motion by Schlaud, seconded by Maasch, **PASSED**, the Mayfield Township Planning and Zoning fee schedule increases, to be effective July 1, 2026 as presented. Kile-aye, Maasch-aye, Frisch-absent, Engelman-aye, Schlaud-aye. Carried.

Motion by Schlaud, seconded by Maasch, **PASSED**, to approve the Mayfield Township parcel split fee to 225.00 per parcel ID, effective July 1, 2026 as presented. All ayes. Carried.
